Mr. Reynolds informs the Committee that to the best of his knowledge the death was due to natural causes and not in any way concerned with the duties of fireman, and he feels that to pay this would be setting a bad precedent for future occasions. The authority for making these payments being predicated on a man receiving injuries resulting from death while in line of duty in the Fire Department.

On motion of Mr. Testa, seconded by Mr. O'Connor it is voted not to pass said ordinance.

Michael N. Cardarelli, Revenue Administrator and Albert A. Gallotta, City Assessor, join the Committee at this time for the purpose of discussing with them the following Resolutions:

RESOLUTION PROVIDING FOR THE ASSESSMENT AND COLLECTION OF 1946 TAXES IN A SUM NOT LESS THAN \$13,150,000.00 NOR MORE THAN \$13,450,000.00.

Mr. Gallotta states that the purpose of their appearance is to appear before the Committee and have them set the maximum and minimum tax rates in accordance with their annual practice.

Mr. Gallotta briefly describes the general tax picture to the Committee showing possible gains over previous years and losses from previous years; particularly pointing out that Veterans' exemptions will be considerable and recommends that the maximum and minimum rates be in accordance with the above resolution.

Messrs. Cardarelli and Gallotta are excused at this time.

On motion of Mr. Testa, seconded by Mr. O'Connor it is voted to recommend passage of the above resolution at the next meeting of the City Council.
