- 1. An Ordinance in Amendment of Chapter 16 of the Code of Ordinances of the City of Providence, Entitled: "Offenses and Miscellaneous Provisions," to create Section 23, "Opt-In Requirement for Mass Outdoor Deliveries."**

- 2. An Ordinance in Amendment of Chapter 2 of the Code of Ordinances of the City of Providence Entitled "Administration," Amending Section 2-6, "Description of Municipal Medal," and Section 2-8, "Acts of Bravery or Valor Warranting Receipt of Medal."**

VICE-CHAIRMAN PRINCIPE: I make a motion to substitute.

COUNCILWOMAN RYAN: Second.

On motion of Vice-Chairman Principe, Seconded by Councilwoman Ryan, it is voted to substitute item 2 with 2A.

CHAIRMAN HASSETT: Discussion. All those in favor.

COMMITTEE: Aye.

CHAIRMAN HASSETT: Opposed. The “Ayes” have it. Now, we have a substitution in front of us, Section 2-7, second line where it says “in the line of his” insert “or her” duty.

VICE-CHAIRMAN PRINCIPE: So moved.

On motion of Vice-Chairman Principe, Seconded by Councilwoman Ryan, it is voted to amend Section 2-7, second line, “in the line of his” by adding “or her”.
