The Committee on Urban Redevelopment, Renewal and Planning, meets this day at 7:30 o'clock p.m. in the Department of City Clerk, City Hall.

Present: Councilman Thomas F. O'Connor, Jr., Chairman, Councilman David G. Dillon and Councilwoman Brassil.

Also present were Thomas V. Moses, Department of Planning and Development, Raymond Mannarelli, Assistant City Solicitor, John Palmari, Planning and Development and Michael R. Clement, Assistant Clerk.

AN ORDINANCE IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1979-26 OF THE ORDINANCE OF THE CITY OF PROVIDENCE APPROVED JUNE 22, 1979 AND ENTITLED, "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE WEST END PROJECT" FOR ADDITIONAL ACQUISITION AND BUDGET REVISION.

Councilman Dillon states that although there were some objections to the above Ordinance at the Public Hearing, but feels that they are not enough to hold up the Ordinance and therefore would move passage of the Ordinance. Councilman Dillon also stated that a section of the Ordinance should be amended to clarify where the additional monies are coming from, and amendment should read as follows.

REVISED TOTAL ESTIMATED PROJECT COST: \$1,700,000
THE ADDITIONAL \$700,000 PROJECT COST WILL BE PROVIDED FROM THE FUNDS DERIVED FROM THE SALE OF PARCELS 4 AND 24 WITHIN THE WEYBOSSET HILL PROJECT. THE DISPOSITION LAND PROCEEDS AS THE RESULT OF THIS PLAN AMENDMENT WILL BE RETAINED FOR PROJECT ACTIVITIES AND BE MADE A PART OF THE PROJECT AMENDMENT.

On motion of Councilman Dillon, and seconded by Councilwoman Brassil, it is voted to amend the said ordinance with the above wording.

RELATIVE TO AN ORDINANCE AUTHORIZING THE PROVIDENCE REDEVELOPMENT AGENCY TO CREATE A SPECIAL PROJECT AREA FOR THE PURPOSE OF ACQUIRING AND DISPOSING OF VACANT LAND WITHIN THE CITY AND PROVIDING FOR THE SYSTEMATIC FORECLOSURE OF CITY LIENS, AS AMENDED.

On motion of Councilman Dillon, and seconded by Councilwoman Brassil, it is voted to recommend passage of the abovesaid Ordinance and transmit the same to the City Council as Amended.
