AN ORDINANCE IN AMENDMENT OF CHAPTER 1979-37 APPROVED SEPTEMBER 28, 1979, ENTITLED: "AN ORDINANCE REGULATING THE USE OF INTERCEPTORS, PUBLIC AND PRIVATE SEWERS AND DRAINS, THE INSTALLATION AND CONNECTION OF BUILDINGS SEWERS AND GARBAGE DISPOSAL UNITS, THE DISCHARGE OF WATER AND WASTEWATER INTO THE PUBLIC SEWERAGE SYSTEM AND PROVIDING FOR THE ENFORCEMENT OF THESE RULES AND REGULATIONS AND COST RECOVERY PROGRAM IN THE CITY OF PROVIDENCE, COUNTY OF PROVIDENCE, STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS", AS AMENDED.

A motion was made by Councilman Easton, seconded by Councilman Dillon, to amend the Ordinance to reflect a tax credit on the property tax at the rate of 75% for home owners and 50% for commercial and industrial users.

Councilman Mansolillo desires to be recorded as voting "No."

Councilman Flynn desires to be recorded as "Not Voting".

Councilman Paolino requests the proposal be referred to Internal Auditor Woerner and Administrative Assistant to the City Council Sheehan for drafting.

A motion is made by Councilman Paolino to try to determine how an Ordinance can be drafted that will include usage for homeowners in lieu of a flat fee.

There is no second to the motion.

A motion is made by Councilman Easton, seconded by Councilmen Paolino and Dillon, to amend the Ordinance by adding a new Section

APRIL 19, 1982

14, which has been submitted by the Narraganset Bay Commission and change Section 14 to Section 15.
