Budget Officer Moran outlines the following Ordinances:

AN ORDINANCE AMENDING CHAPTER 886 BY ADDING THE SUM OF TEN THOUSAND (\$10,000) DOLLARS TO THE APPROPRIATION CONTAINED THEREIN FOR POLICE DEPARTMENT, ITEM 1. (In City Council March 3, 1955. Read and Passed the first time.)

This Ordinance adds \$10,000.00 to Police Department, Item 1. This appropriation would be used for alterations at police headquarters in the space formerly occupied by the Bureau of Licenses and is made necessary by the consolidation of precincts. Charge to Reserve for Extraordinary Expenditures.

AN ORDINANCE AMENDING CHAPTER 886 BY ADDING THE SUM OF ELEVEN THOUSAND FIVE HUNDRED (\$11,500) DOLLARS TO THE APPROPRIATION CONTAINED THEREIN FOR POLICE DEPARTMENT, ITEM 5. (In City Council March 3, 1955. Read and Passed the first time.)

This Ordinance adds \$11,500.00 to Police Department, Item 5, for the purchase of three motorcycles (3 wheel), steel lockers and office equipment. Charge to Reserve for Extraordinary Expenditures.

On motion of Mr. O'Connor, seconded by Mr. Lazarus, it is voted to return the above Ordinances to the City Council with recommendation of passage a second time.
