DISPOSITION: VOTED: that the Purchasing Director hereby authorizes approval of Budgetary Change Order #1, with Sonitrol Security of Rhode Island, for RFP for Monitoring & Maintenance of Electronic Security System-3 Year Contract with 2-One Year Options/Plant Maintenance & Operations-Local, in the amount of Fifteen Thousand Seven Hundred Twenty Eight (\$15,728.00) Dollars for the 16/17 year, to install security cameras at E-Cubed Academy School, for a revised total amount not to exceed Three Hundred Thirty Four Thousand Seven Hundred Fifty Three Dollars and Sixteen (\$334,753.16) Cents, all in accordance with the request of Judith Petrarca, Purchasing Administrator, in communication dated August 1, 2016.


On June 29, 2015 the Board of Contract and Supply awarded RFP for Monitoring & Maintenance of Electronic Security System-3 Year Contract with 2-One Year Options/Plant Maintenance & Operations-Local/School Department to Sonitrol Security of Rhode Island (Sole Bidder) The Providence School Department/Plant Maintenance & Operations/Local respectfully requests the Board of Contract and Supply to **extend this award with Sonitrol Security of Rhode Island for three additional years from July 1, 2015-June 30, 2018 as per attached agreement negotiated by Alan Sepe, Director of Operations for the City as below and also awarded an additional \$10,000.00/year for 3 years for emergencies not covered under this agreement. The security devices are proprietary to Sonitrol.**

\$311,244.00 FY 2015/2016 (Same cost as 2014/2015)
\$319,025.16 FY 2016/2017(2.4% increase above 2015/2016)
\$330,190.92-FY 2017/2018(3.4% increase above 2016/2017)

The Providence School Department requests the Board of Contract to approve budgetary change order #1 in an amount not to exceed \$15,728.00 for the 16/17 year for a revised amount not to exceed \$334,753.16. Additional funds are needed to install security cameras at E-Cubed Academy School. (See attached.)
