VIZ:

ADRIAN HALL WAY, running from Washington Street to Fountain Street, approximately ____ square feet plus or minus, shown as the cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-E-F), is proposed to be temporarily closed for a period of ten years in order to permit the development of the Parks Department's skate park on the adjacent property, and to continue to serve as a loading area for the Trinity Repertory Company. The temporary closure is specifically conditioned upon the following:

- (1) Petitioner shall not be required to pay for the temporary closure.
- (2) Existing utility easements in favor of Verizon, National Grid, and the Providence Water Supply Board shall be unaffected by the temporary closure.
- (3) Petitioner shall comply with all conditions contained herein, including recording this Resolution, not later than sixty (60) days from its approval. Upon failure to so comply for any reason, the within resolution shall automatically become a nullity.
- (4) Such other conditions as the Mayor or the Law Department shall see fit to impose.
