Finance Director Keegan outlines the following Resolutions.

RESOLUTION REQUESTING AND URGING THE SCHOOL COMMITTEE AND THE BOARD OF CONTRACT AND SUPPLY TO COOPERATE WITH THE STATE BOARD OF EDUCATION IN CENTRALIZING WITH OTHER RHODE ISLAND COMMUNITIES, THE PURCHASING OF COMMON SCHOOL SUPPLIES AND BOOKS TO FOSTER ECONOMIES.

RESOLUTION REQUESTING THE SUPERINTENDENT OF SCHOOLS TO SUBMIT WITHIN 30 DAYS TO ALL OF THE MEMBERS OF THE CITY COUNCIL AND THE FINANCE DIRECTOR AS WELL AS THE MAYOR, CERTAIN INFORMATION RELATIVE TO RECEIPTS AND EXPENDITURES.

After a lengthly discussion by various members of the Committee it was voted that an invitation be extended to Councilman Thomas W. Pearlman to appear before the next Finance Committee meeting.

On motion of Mr. McOsker, seconded by Mr. Lazarus it is voted that the above resolutions be continued for further study.

RESOLUTION REQUESTING THAT BACK TAXES FOR 1961, 1962, 1963 AND 1964, FOR PROPERTY LOCATED AT SOUTH MAIN AND INDIA STREETS, BELONGING TO THE NEW HAVEN RAILROAD COMPANY, BE ABATED.

Assistant City Schicitor Vincent Piccirilli gave the opinion of the City Solicitor's Department and Mr. Keegan introduced a letter which is on file in the Department of City Clerk.

On motion of Mr. Haxton, seconded by Mr. Lynch it is voted to continue this resolution indefinitely.

RESOLUTIONS REFUNDING TO CERTAIN TAXPAYERS SPECIFIED AMOUNTS OF MONEY REPRESENTING OVER-PAYMENT OF 1959 TO 1964, INCLUSIVE, TAXES TO THE CITY COLLECTOR.
